

## Terms and Conditions for National Clubs Carnival Entries

## COVID-19 Notice

Due to the ongoing impact and ever-changing nature of the COVID-19 virus, Gymnastics Australia may not be able to deliver a full Australian Gymnastics Championships program in 2022 as planned. All decisions will be made based on credible evidence and in the best interest of the health of all involved. Final decisions on event delivery and operations will be in line with both Federal and State guidelines and restrictions. All events will be delivered in line with Gymnastics Australia's COVID Safe Plan.

- Clubs must be affiliated with Gymnastics Australia to be eligible to enter the competition
- All prices quoted include GST.
  - o Provisional Entries: \$60 per club per GymSport
  - o Definitive Entries: \$170 per athlete per GymSport
- Clubs are required to make full payment within 14 days of receiving their invoice to either guarantee your entries (if a provisional entry was registered by the Club for the Gymsport) or your place on the waitlist (if a provisional entry was not registered by the Club for the Gymsport).
- If your club is on a wait list due to provisional entries not being submitted, your wait list position is not confirmed until full payment is received. If any entries are not successful, you will not receive an invoice
- Waitlisted clubs will be informed by Gymnastics Australia within 2 weeks of the close of entries should their entries be accepted or not
- Clubs must ensure that all Coaches and Judges registered for their Club have a <u>current</u> relationship registered at the Club in the Club Admin Portal> Tech Member tab before registering them at this event.
- Clubs must ensure that all Coaches and Judges registered for their Club have a current and valid WWCC or equivalent registered at the Club in the Club Admin Portal> <u>WWCC Check</u> tab before registering them for this event. Coaches and Judges who do not hold <u>current and</u> valid WWCC or equivalent accreditation will not be permitted into the event.
- Clubs must ensure that all Coaches and Judges registered for their Club hold a <u>current</u> Technical Membership before registering them for this event.
- Athlete entries are eligible if they are registered to the club in the <u>Club Admin Portal</u> with a paid thru date of 31/12/2022 and if they have been <u>allocated</u> an <u>Athlete Code</u> (Gymsport and Level) that is in the <u>Gymsport</u> they are competing in.
- Only Athletes who have opted in and paid for a levels test are eligible for a Levels Test at the event
